#### Overview

#### Background

- The Mercers' Company has been supporting work in area of Transitions from Secondary Education since 2019 and has so far funded 15 organisations across three cohorts in Phase 1. All grantees deliver effective programmes which support disadvantaged young people to move successfully from secondary education.
- Making a successful transition into work, further or higher education, or training is critical to a young person's life chances.
  Young people from disadvantaged background can often face additional barriers making this transition every more difficult.

### Outcomes

#### Work must help disadvantaged young people to:

- Gain access to progression pathways including further or higher education, apprenticeships, traineeships and other similar programmes
- Build experience and knowledge of work including career specific work experience
- Develop social and emotional capabilities including communication, leadership and resilience

- General appeals or financial support for project costs that have already been incurred

Stage 2: Full application

- More detail to build on your EOI
- Shortlisted applications will be given further information
- Assistance available from Mercers' YP&E team



#### What we offer

- Funding: Between £120,000 and £350,000 in total per organisation paid across three years
- Learning partner support: Grantees will be required to work with them as part of a programme wide evaluation
- Cohort approach: creating opportunity for collaboration
- Capacity building support: through trusted partners

Assessment and due diligence	December 2024 - January 2025	
Decisions made and organisation informed of the outcome	Mid-March 2025	
Projects to start	By 1 October 2025	
First payment of funding granted to successful applicants	April 2025 onwards
